bounden Principal shall on and after the 20th day of November
indemnify said Obligees against all loss, costs, expenses or damage to it caused by said Principal's non-compliance
with or breach of any laws, statutes, ordinances, rules or regulations pertaining to such license or permit, then the
above obligation shall be void, otherwise to be and remain in full force and effect.

PROVIDED, the term of this bond shall be from the 20th day of November,
19 85 to 31st day of December, 19 86 and may be continued from year to year
by Certificate executed by the Surety hereon.

AND, PROVIDED, the Surety may cancel this bond at any time by giving thirty (30) days notice in writing
mailed to the Obligees.

PROVIDED FURTHER, regardless of the number of years this bond shall continue or be continued in
force and of the number of premiums that shall be payable or paid, the Surety shall not be liable hereunder for a
larger amount, in the aggregate, than the amount of this bond.

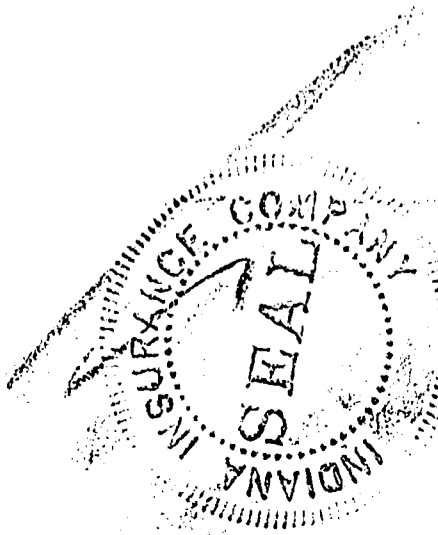
