This cause came on to be heard this day day January, 1986, upon the final account, petition to settle and allow account and for authority to distribute estate filed by VICTOR J. And it appearing that no objections were filed thereto and the court being fully advised in the premises, now finds:

4. Your Executor has heretofore distributed the specific devises provided for by decedent in the Second Provision of her Last Will and Testament as set forth in the final report herein as evidenced by the vouchers filed herein.

NOW, THEREFORE, IT IS ORDERED AND DECREED by the Court as follows:

- 1. Said report and account of said Executor is hereby in all things approved, settled and confirmed.
- 2. Said Executor is hereby directed to distribute and pay over the balance of said account on hand in the sum of \$29,508.98 to MARY HELEN KARLSSON, granddaughter and sole residuary devisee.
- 3. Pursuant to decedent's will, the real estate which she died seized and which was undisposed of by sale or otherwise during the period of this administration, more particularly described as follows:

Said Executor is hereby directed to file herein its Supplemental Report of Distribution and attach thereto receipts and vouchers showing that the balance of the assets have been distributed pursuant to the terms of this order and that said Executor has in all things carried out the provisions of this final decree.
