MARY LOUISE MAURER, being first duly-sworn under oath, deposes and says:

1. That she is an adult-daughter of Mary Slivka and Joseph Slivka, husband and wife.

2. That the undersigned's father, Joseph Slivka, died on November 2, 1977 and was survived by his wife, Mary Slivka, who then became the sole owner of the following-described real estate, to-wit:

That the above-described real estate was acquired by the aforesaid parents of the undersigned affiant as husband and wife, and that they continued to hold said real estate continuously as husband and wife, from the time they acquired the same, until the date of death of the undersigned's father, Joseph Slivka, on November 2, 1977.
