
in fee simple absolute, pursuant to the provisions of the decedent's Last Will and Testament.

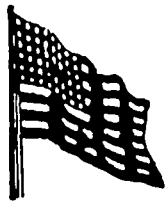
