This cause came to be heard on the 12th day of February, 1986, upon the Final Account, Petition to Settle and Allow Account and For Authority to Distribute Estate filed by Henry A. Mysliwy, as Executor of the Estate of Henry Patrick Mysliwy, deceased, which Account and Petition are in the words and figures following, to-wit:

And it appearing that no objections were filed thereto and the Court being fully advised in the premises now finds that:

1. Due notices of the filing of said Account and Petition and of the hearing on the same were given to all persons interested in said Estate, and the same are now properly before the Court for final action thereon.

2. That Henry Patrick Mysliwy, died testate, a resident of Lake County, State of Indiana, on the 22nd day of February, 1981, and his Last Will and Testament was duly admitted to probate before this Court on the 25th day of March, 1981, and this Court appointed said Henry A. Mysliwy as Executor of the Last Will and Testament of the decedent, and said Executor was issued Letters Testamentary on the 1st day of April, 1981, and since that date he has continued to serve in such capacity.

3. That the matters and things stated in said Account and Petition are true, and that said Executor has accounted for all the assets in said estate coming into his hands.

4. More than five (5) months have elapsed since the date of first published notice to legatees, devisees and creditors of said decedent, no claims have been filed against said estate; neither

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED by the Court as follows:

1. Said Final Report and Account of said Executor is hereby in all things approved, settled and confirmed.

2. That the distribution of the balance of the property remaining in said Executor's hands for distribution should be made pursuant to the distribution set forth in the Final Accounting and as prescribed under the Last Will and Testament of said decedent and is hereby in all things approved.

3. That pursuant to the decedent's Last Will and Testament the following described real estate, to-wit:

The South 48.87 feet of Lot 8 and the North 10 feet of the vacated portion of 171st Street, in L.N. Cook Addition to the City of Hammond, in Lake County, Indiana; and commonly known as 7051 Schnieder Avenue, Hammond, Indiana,

is hereby vested in June Eleanor Mysliwy, the surviving spouse of the decedent, in fee simple absolute, pursuant to the provisions of the decedent's Last Will and Testament.

Ant that the Executor is hereby directed to procure and record in the Office of the Recorder of Lake County, being the county in which said real estate is located, a certified copy of this Final Decree.

4. That pursuant to the decedent's Last Will and Testament the decedent's beneficial interest in the following described real estate, to-wit:

Lot 15, in Ridgeland Addition to the Town of Highland, as per plat thereof, recorded in Plat Book 38, page 19, in the Office of the Recorder of Lake County, in Lake County, Indiana, and commonly known as 2617 40th Place, Highland, Indiana,

is hereby vested in Henry A. Mysliwy, the son of the decedent, in fee simple absolute, pursuant to the provisions of the decedent's Last Will and Testament.

And that the Executor is hereby directed to execute and deliver, to Mercantile National Bank of Indiana, as Trustee, under Trust Number 2884, a Direction to convey said real estate by Trustee's Deed to said Henry A. Mysliwy, the son of the decedent and devisee of said real estate pursuant to the provisions of the decedent's Last Will and Testament.

5. That pursuant to the decedent's Last Will and Testament the decedent's beneficial interest in the following described real estate, to-wit:

Lot 16, in Ridgeland Addition to the Town of Highland, as per plat thereof, recorded in Plat Book 38, page 19, in the Office of the Recorder of Lake County, in Lake County, Indiana, and commonly known as 2611 40th Place, Highland, Indiana,

is hereby vested in the decedent's three sons, Henry A. Mysliwy, Charles H. Mysliwy and Ronald H. Mysliwy, as tenants-in-common, each to hold an undivided one-third (1/3) interest in the whole of said property.

And that the Executor is hereby directed to execute and deliver to Mercantile National Bank of Indiana, as Trustee, under Trust Number 2884, any and all documents or assignments of the beneficial interest of the decedent to said real estate as the Trustee may require to convey said interest to the decedent's three sons, Henry A. Mysliwy, Charles H. Mysliwy and Ronald H. Mysliwy, as tenants-in-common, with each to hold an undivided one-third interest in the whole of said property.

6. Said Executor is hereby directed to file his Supplemental Report showing that he has complied with the terms of this Order and that said Executor has in all things carried out the provisions of this Final Decree.

All of which is Ordered this 12th day of February, 1986.

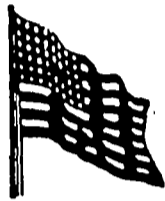
