1. Due notices or waives of the filing of said account and
petition and of the hearing on the same were given to all persons
interested in said estate, and the same are now properly before the
Court for final action thereon.

2. That Catherine M. Kosiba, died testate, a resident of
the County of Lake, State of Indiana, on June 12, 1985, and her Last
Will and Testament was duly admitted to probate before this Court on
June 26, 1985, and this Court appointed said Richard Banchich as
Administrator With Will Annexed of the Last Will and Testament of
the decedent, and said Administrator With Will Annexed was issued
Letters of Testamentary on July 12, 1985, to him, and since that
date he has continued to serve in such capacity.

3. That the matters and things stated in said account and
petition are true, and that said Administrator With Will Annexed has

3. That pursuant to the decedent's Last Will and Testament the following described real estate, to-wit:



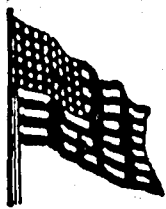
