- Due notices or waives of the filing of said account and petition and of the hearing on the same were given to all persons interested in said estate, and the same are now properly before the Court for final action thereon.
- That Catherine M. Kosiba, died testate, a resident of the County of Lake, State of Indiana, on June 12, 1985, and her Last Will and Testament was duly admitted to probate before this Court on June 26, 1985, and this Court appointed said Richard Banchich as Administrator With Will Annexed of the Last Will and Testament of the decedent, and said Administrator With Will Annexed was issued Letters of Testamentary on July 12, 1985, to him, and since that date he has continued to serve in such capacity.
- That the matters and things stated in said account and petition are true, and that said Administrator With Will Annexed has accounted for all the assets in said estate coming into his hands.

- More than five (5) months have elapsed since the date of first published notice to legatees, devisees and creditors of said decedent; all claims filed against said estate have been paid and discharged; neither said decedent nor her Administrator With Will Annexed was an employer of labor within the meaning of that term as used in the Indiana Employment Security Act; all estate taxes, inheritance taxes and gross income taxes, if any, assessed in said estate have been paid.
- The following persons are the sole legatees and devisees under the decedent's Last Will and Testament:

and that all assets and property of this estate remaining after payment of decedent's debts and expenses of administration have been distributed to the above-named persons, as evidenced by their receipt which is attached hereto and made a part of this accounting.

6. That the decedent owned a certain piece of real estate located at 4344 Torrence Avenue, Hammond, Indiana, more particularly described as follows:

- 3. That pursuant to the decedent's Last Will and Testament the following described real estate, to-wit:

Lots 28 and 29 in Block 7 in Rolling Mill Addition to the City of Hammond, as per plat thereof, recorded in Plat Book 1, page 105, in the Office of the Recorder of Lake County, Indiana

is hereby vested in Robert Banchich, Richard Banchich, Stephen S.
Banchich and Jeri Lee Banchich Edwards pursuant to the provisions of
the decedent's Last Will and Testament.

And that said Administrator With Will Annexed is hereby directed to procure and record in the office of the Recorder of Lake County, being the county in which said real estate is located, a certified copy of this Final Decree.

- 4. Said Administrator With Will Annexed having made distribution of all assets and property and having attached receipts evidencing said distribution to said legatees and devisees, said distribution is hereby approved and confirmed.
- 5. Said Administrator With Will Annexed is hereby released and discharged from any further liability or responsibility along with his surety as said Administrator With Will Annexed of the estate of Catherine M. Kosiba. Estate ordered closed. All of which is ordered this day of March, 1986.
