NOTE AND MORTGAGE EXTENSION AND MODIFICATION AGREEMENT

SEBERGER JR., in the sum of ONE HUNDRED SIXTY THOUSAND (\$160,000.00) Dollars; said mortgage was recorded on April 1, 1981 as Document No. 623234 in the Recorder's Office of Lake County, Indiana; and

WHEREAS, it is the desire of the Second Party to extend the time of paying of the balance of this note for a period of 3 yrs., from March 1, 1986 to March 1, 1989 with principal and interest payments of \$2,000.00 due monthly, and with interest at the rate of ELEVEN and ONE QUARTER per cent (11½%) per annum rather than TWELVE per cent (12%) per annum.
