ASSIGNMENT OF MORTGAGE

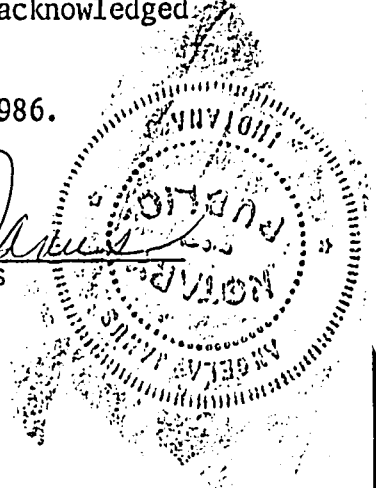
