This cause came to be heard on the 16 day of Sept.,
1986, upon the final account, petition to settle and allow
account and for authority to distribute estate filed by
Richard Wayne Harbrecht, as executor of the estate of Walter
Carl Harbrecht, deceased, which account and petition are in
the words and figures following, to-wit:

And it appearing that no objections were filed there
and the Court being fully advised in the premises now find
that:

1. Due notices of the filing of the said account and
petition and of the hearing on the same were given to all
person is interested in said estate, and the same are now
properly before the Court for final action thereon.
2. That Walter Carl Harbrecht, died testate, a resident
of the County of Lake, State of Indiana, on the 1st day of
September, 1935, and his Last Will and Testament was duly
admitted to probate before this Court on the 22 day of
October 1936, and this Court appointed said Richard Wayne
Harbrecht as executor of the Last Will and Testament of the
decedent, and said executor was issued Letters of
Testamentary on the 22 day of October 1935 to him and since
that date he has continued to serve in such capacity.
3. That the matters and things stated in said account
and petition are true, and that said executor has accounted
for all the assets in said estate coming into his hands.
4. More than five (5) months have elapsed since the
date of first published notice to legatees, devisees and

of that term as used in the Indiana Employment Security Act; all estate taxes, inheritance taxes and gross income taxes, if any, assessed in said estate have been paid.

5. The following persons are the sole legatees and devisees under the decedent's Last Will and Testament:

a. Richard Wayne Harbrecht, son and 1/2 heir

b. Thomas Francis Harbrecht, son and 1/2 heir

and that said distribution should be made to the above named parties as set forth above.

6. That the decedent owned 253 Vine Street, Hammond, Indiana, County of Lake as joint tenants with right of survivorship and said real estate upon decedent's death vested in the survivors.

7. That heir Thomas Francis Harbrecht herein owed decedent the sum of \$20,000.00 as secured by a mortgage on his property at 7461 Wilson Place, Merrillville, Indiana (Document No. 632268 Mortgage Record 531598 p. 114, Book 43 Lake County, Indiana) and that as part of his share of the Estate under the will has agreed to accept a mortgage satisfaction and release from Executor herein and that said satisfaction and release is hereby approved and authorized.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED by the Court as follows:

1. Said Final Report and Account of said executor is hereby in all things approved, settled and confirmed.

2. That the distribution of the balance of the property remaining in said executor's hands for distribution should be made pursuant to the distribution set forth in the final accounting as prescribed under the Last Will and Testament of said decedent and is hereby in all things approved.

3. That Executor is authorized to execute Mortgage Satisfaction and Release for \$20,000.00 Mortgage on property at 7461 Wilson Place, Merrillville, Indiana (Document No. 632268 Mortgage Record 531598 p. 114 Book 43, Lake County, Indiana) as part of the share of Thomas Francis Harbrecht in this Estate.

And that said executor is hereby directed to procure and record in the office of the Recorder of Lake County, being the county in which said real estate and mortgage release


Satisfaction hereinbefore mentioned is located, a certified copy of this Final Decree.

4. Said executor is hereby directed to distribute the balance of the assets available for final distribution pursuant to the provisions of the decedent's Last Will and Testament as follows:

1. Richard Wayne Harbrecht \$22,984.52 being comprised of A) 1/2 household furnishings 253 Vine St., B) Quit claim deed to 253 Vine St., for equity in property after payment of estate debts and expenses.

2. Thomas Francis Harbrecht A) Release of mortgage-p. 114, Book 43, Document No. 632368 \$20,000.00 B) 1/2 of household furnishings 253 Vine St., Hammond, Indiana C) Cash in the sum of \$2998.24.

5. Said Executor is hereby directed to file his Supplemental Report showing that he has complied with the terms of this order and that said executor has in ^{all things} carried out the provisions of this final decree. ^{by attached deed} All of which is ordered this 16 day of Sept, 1986.
