PROMISORY NOTE AND LOAN MODIFICATION AGREEMENT

THIS AGREEMENT, is entered into by and between American Savings & Loan Association, a corporation, organized and existing under the laws of the State of Indiana, hereinafter referred to as Lender, and Joseph P. - A. The Borrowers (jointly and severally) promise and agree to pay to the order of Lender the sum of \$59,863.11, payable in monthly installments of \$634.17, with interest at 9.75% per annum, including principal and interest, commencing on the 5th day of October, 1986, and a like sum on the 5th day of each and every month thereafter, until the principal and interest are paid in full except that the final payment of the entire indebtedness evidenced hereby shall be due and payable on the 5th day of October 2001, if not paid sooner, all without relief from valuation and appraisement laws and with attorney fees in the even of default.
- B. In addition to the installments of principal and interest as set out heretofore, Borrowers hereby reaffirm and agree to abide by all of the terms, conditions and covenants contained in the aforesaid Real Estate Mortgage and Notemas modified herein.
- C. Borrowers specifically agree, represent and acknowledge that proper legal and adequate consideration is being given them to enter into this greement and that Borrowers are and continue to be legally bound and obligated for, by and under said indebtedness.
- D. The Borrowers further agree that all terms, conditions and covenants of the aforesaid indebtedness shall remain unaltered and in full force and effect except as herein expressly modified.
