A parcel of land in the Northeast Quarter of Section 17, Township 35 North, Range 9 West, of the Second Principal Meridian, in the Town of Schererville, Lake County, Indiana, being more particularly described as follows: Commencing at the intersection point of the center line of U.S. Highway #41 and the center line of U.S. Highway #30 as presently laid out and as shown on a plat of survey prepared by Earl Goldberg, P.E., dated June 10, 1985. Said point also lying 12.70 feet more or less West along the center line of U.S. Highway #30 from the East line of said Section 17, and 978.70 feet more of less South of the Northeast corner of said Section 17 as measured along the East line of said Section 17; thence North 89 degrees 32 minutes 21 seconds West (all bearings are assumed) 155.01 feet along the center line of U.S. Highway #30; thence North at right angles to the center line of U.S. Highway #30 a distance of 57.00 feet to a point on the North right-of-way line of U.S. Highway #30, said point being the point of beginning; thence North 89 degrees 32 minutes 21 seconds West 161.00 feet along the said North right-of-way line of U.S. Highway #30; thence North O degrees 27 minutes 39 seconds East 97.78 feet; thence North 49 degrees 21 minutes 14 seconds East 180.46 feet; thence North 90 degrees 00 minutes 00 seconds East 120.00 feet to the West right-of-way line of U.S. Highway #41; thence South 0 degrees 27 minutes 09 seconds West 134.51 feet along the West right-of-way line of U.S. Highway #41; thence South 49 degrees 21 minutes 14 seconds West 126.07 feet to the point of beginning.
