FIRST: I hereby revoke all Wills and Codicils heretofore made by me.

SECOND: I hereby declare that THERESA MARIE BARBUCHECK is my beloved wife, and that no issue has resulted from our blessed marriage.

THIRD: I order and direct that my just debts and funeral expenses be paid as soon after my death as may be reasonable convenient, and I hereby authorize my Executrix, hereinafter named, to settle and discharge any claims against my estate in her absolute discretion.

FOURTH: I hereby give, devise and bequeath unto my beloved wife, THERESA MARIE BARBUCHECK, my entire estate, whether of real, personal, or mixed nature, wherever the same may be lying or situated, which I own, or in which I may have an interest at the time of my death, absolutely and forever.

FIFTH: In the event that my beloved wife, THERESA MARIE BARBUCHECK, predeceases me, or shall not survive me by sixty (60) days, I hereby order and direct my Executor to distribute my estate as follows:

- (a) To the ST. MARK'S ROMAN CATHOLIC CHURCH of Gary, Indiana, the sum of Five Hundred

Dollars (\$500.00) for Holy Masses to be offered at the aforesaid church in memory of, and for the repose of the Sould of myself and my beloved wife, THERESA MARIE BARBUCHECK.

- (b) All the rest, residue and remainder of my estate, whether of a real, personal, or mixed nature, wherever the same may be lying or situated, which I own, or in which I may have an interest at the time of my death, shall be given, devised and bequeathed, subject to the foregoing provisions, unto my grand niece, Helen Okonski and grand niece-in-law, Virginia Wirtes; and in the event that they predecease both my beloved wife and me, then to their lawful issue, per stirpes, absolutely and forever.

SIXTH: I hereby constitute and appoint my beloved wife, THERESA MARIE BARBUCHECK, Executrix of this, my Last Will, and I further authorize and direct that she shall be exempt from furnishing any bond required for the faithful performance of her duties hereunder. In the event that she predeceases me, or because of any incapacity to act as such Executrix, then, and in that event, I nominate and appoint the Bank of Indiana, of Gary, Indiana, as Executor in her place.

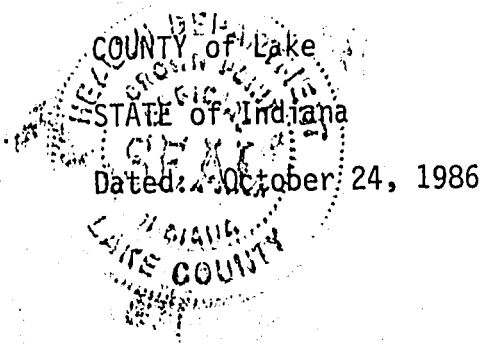
