PARTIAL SATISFACTION OF ASSIGNMENT OF LEASES

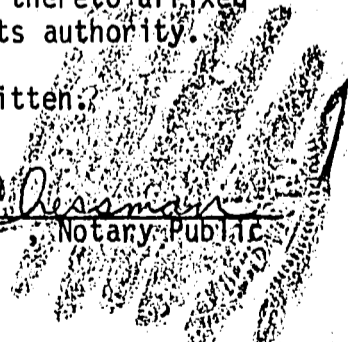
