is hereby vested in DELLA J. GATES, BARRY EDMOND GIBSON, WARREN ARNOLD GIBSON AND JUDY VOLENE MILLER, as to an undivided one-half (1/2); one-sixth (1/6); one-sixth (1/6) and one-sixth (1/6) interest respectively, as tenants in common; and

4. That said Administratrix is hereby release and discharged from any further liabilities or responsibilities, along with here surety, as Administratrix of the Estate of MARCELLA BEATRICE GIRON, deceased.
