INDEMNIFYING MORTGAGE

THIS INDENTURE WITNESSETH, THAT FIRST NATIONAL BANK OF EAST CHICAGO, INDIANA
as Trustee, under Trust Agreement dated June 20, 1981, known as Trust No. 10.0126
9175 CALUMET AVENUE, MUNSTER, INDIANA LAKE County, in the State of Indiana,

hereby mortgage and warrant to the First National Bank of East Chicago, Indiana, Lake County, Indiana, the
following described property in the County of LAKE and State of INDIANA, to wit:

Lot 6 in Twin Creek, Block One to the Town of Munster, Lake County, Indiana as
recorded in Plat Book 48, page 68 in the Office of the Recorder of Lake County,
Indiana, and commonly described as 9847 Twin Creek Boulevard, Munster, Indiana.

This instrument executed by the First National Bank of East Chicago, not personally,

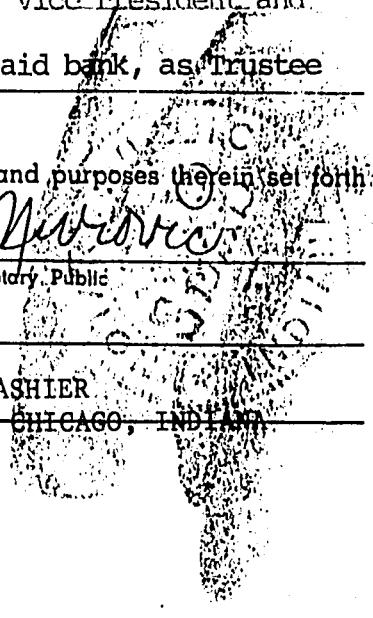
