That part of the Southeast Quarter of Section 5, Township 32 North, Range 9 West of the 2nd P.M., in Lake County, Indiana, more particularly described as follows: Commencing at a point 2049.10 feet North of the Southeast corner of the above said Section 5 (this point being the interesection of Highway U.S. No. 41 and State Road No. 2); thence North on said Section line 313 feet (this point being the beginning of this description); thence continuing North along the East line of said Section 280.85 feet to the Northeast corner of the Southeast Quarter of said Section 5; thence West along the North line of said Southeast Quarter 308.80 feet; thence South parallel with the East line of said Section 310.10 feet; thence Northeasterly 310.31 feet to the place of beginning.

Parcel 2:

A roadway easement to pass over, along and across the following described real estate, to-wit: The North Ten (10) feet of the following described Real Estate: That part of the Southeast Quarter of Section 5, Township 32 North, Range 9 West of the 2nd P.M., more particularly described as follows: Commencing at a point 2049.10 feet North of the Southeast corner of said Section 5, (this point being the intersection of U.S. Highway No. 41 and State Road No. 2); thence Southwesterly along the center line of said State Road No. 2, 284 feet; thence North parallel to the East line of the Southeast Quarter of said Section 5, 393 feet; thence in a Northeasterly direction 264.30 feet to a point on the East line of the above said Section 5, which is 313 feet North of the place of beginning; thence South 313 feet to the place of beginning, in Lake County, Indiana; to be used jointly with owner to South; as created in Instrument recorded October 25, 1967, in Miscellaneous Record 962, page 271, as Document No. 727020.
