AFFIDAVIT FOR TRANSFER OF REAL PROPERTY

MARY ELLEN SCHIESSLE being duly sworn upon oath, deposes and says:

1. That MATTHIAS R. KUHN died intestate on the 20th day of November, 1983, while domiciled in Lake County, Indiana.

2. That no petition for the appointment of a personal representative of said decedent is pending in any Court in this State and that fortyfive (45) days have elapsed since the death of the decedent.
