AFFIDAVIT FOR TRANSFER OF REAL PROPERTY

MARY MARSH being duly sworn upon oath, deposes and says:

1. That MICHAEL A. KUHN died intestate on the 26th day of October, 1972, while domiciled in Lake County, Indiana.
2. That no petition for the appointment of a personal representative of said decedent is pending in any Court in this State and that forty-five (45) days have elapsed since the death of the decedent.
3. That the following named persons are the only heirs of the decedent: MELVIN KUHN, son, NORMAN KUHN, son, ANN AYERSMAN, daughter, MARY MARSH, daughter and CHARLES KUHN, son.
4. That the value of the decedent's gross probate estate, less liens and encumbrances, does not exceed the sum of the allowance provided by I.C. 29-1-4-1, the costs and expenses of administration and reasonable funeral expenses.
5. That among the decedent's probate assets is a one-eleventh (1/11th) interest in a parcel of real estate which is commonly known as 48 W. Joliet St., Schererville, Indiana, more particularly described as follows:
