— RELEASES AND QUIT CLAIMS (strike one) to DONALD C. NIEMEYER and YVONNE NIEMEYER husband and wife of LAKE County,

in the State of INDIANA, in consideration of Ten (\$10.00) Dollars and

all other good and valuable consideration the receipt of which is hereby acknowledged, the

following described real estate in LAKE County, in the State of Indiana, to-wit:
