1. Due notices of the filing of said account and petition and of the hearing  
on the same were given to all persons interested in said estate and the same are  
now properly before the Court for final action thereon.

2. That Mildred Ruth Castelich, died intestate, a resident of the County of  
Lake, State of Indiana, on the 31st day of August, 1985, and said Administratrix  
was issued Letters of Administration on the 12th day of December, 1985,  
since that date she has continued to serve in such capacity.

3. That the matters and things stated in said account and petition are true  
and that said administratrix has accounted for all of the assets in this estate  
coming into her hands.

4. More than five (5) months have elapsed since the date of the first published  
notice to the heirs and creditors of said decedent; all claims filed against said  
estate have been paid and discharged; neither said decedent nor administratrix was  
an employer of labor within the meaning of that term as used in the Indiana Employ-  
ment Security Act; all estate taxes, inheritance taxes and gross income taxes, if a  
any, assessed in said estate have been paid.

5. That the decedent died leaving the following heirs at law pursuant to the  
provisions of Indiana Code, I.C. 29-1-2-1, Jacqueline Lou Buse, daughter to decedent,  
and that said decedent died unmarried, leaving no other child or children, nor  
decedents of any predeceased child or children, other than those enumerated above.

6. That the decedent owned a certain piece of real estate located at Lot 1, Block 18, in the County of Lake, State of Indiana, more particularly described as follows:

3. That pursuant to the laws of intestacy the following described real estate, to-wit:

is hereby vested in Jacqueline Lou Buse as tenants in common.

4. Said Administratrix is hereby directed to distribute and pay over the balance of the estate in her hands for distribution as follows: Jacqueline Lou Buse, daughter to decedent, sole heir, \$30,533.03.

5. Said Administrator is hereby released and discharged from any further liability or responsibility along with her surety as said administratrix of the estate of Mildred Ruth Castelich.
