Comes now the plaintiff, Cargill, Inc., by its attorneys, Blaney & Casey, and moves the Court for Default Judgment. Evidence presented. The Court finds that on or about the 24th day of April, 1985 the defendant, Robert Rajkovic, was served with a copy of the complaint and summons by the Sheriff of Porter County.
