AFFIDAVIT OF HEIRSHIP

1. That the above-named decedent HERMAN RAY JACKSON, SR. died intestate on the 25th day of December, 1980, while domiciled in Lake County, Indiana.

2. That the only heir of said decedent is your affiant HERMAN RAY JACKSON, JR., age 28, who is the only child of the decedent and whose current address is 727 King Street, Gary, Indiana, 46406.

3. That the decedent was divorced at the time of his death, and left no surviving spouse.

4. That decedent's sole probate asset was a one-half (1/2) ownership interest in a parcel of real estate located in Lake County, Indiana, more particularly described as follows:
