The said principal and interest to be payable in such places as holders may designate, in writing, in the sum of Two Hundred Ten and no/100 (\$210.00) Dollars monthly installments commencing on the first day of January, 1987 and said sum of Two Hundred Ten and no/100 (\$210.00) Dollars on the first day of each month thereafter until the principal and interest are fully paid. 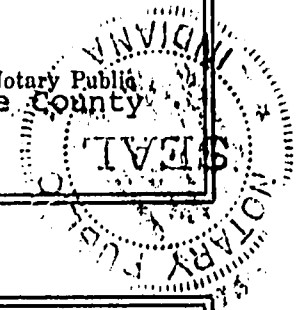
