The enumeration of specific items, rights, acts, or powers herein is not intended to, nor does it, limit or restrict, and is not to be construed or interpreted as limiting or restricting, the general powers herein granted to said attorney in fact.
8. The rights, powers, and authority of said attorney in fact herein granted shall not be affected by lapse of time and shall commence and be effective upon my disability or incapacity to remain in full force for the duration such disability.
