AN ORDINANCE CONFIRMING THE PRELIMINARY ORDINANCE NO. 954 BEING AN ORDINANCE PROVIDING FOR THE VACATION OF A PUBLIC WALKWAY LYING BETWEEN 845 AND 849 TYLER STREET AND 904 AND 908 HARRISON STREET AND PROVIDING FOR THE ADDITION OF A PROPORTIONATE PART OF SUCH WALKWAY TO THE ABUTTING LAND, ALL IN THE TOWN OF DYER, LAKE COUNTY, INDIANA.

WHEREAS, by Ordinance No. 954 adopted on the 8th day of July, 1975, the Board of Trustees of the Town of Dyer, Lake County, Indiana, did provide for the vacation of a public walkway lying between 845 and 849 Tyler Street and 904 and 908 Harrison Street and providing for the addition of a proportionate part of such walkway to the abutting land, all in the Town of Dyer, Lake County, Indiana, by preliminary ordinance, and

whereas, notice was given that the Board of Trustees would hold a public hearing on August 12, 1975 to receive or hear remonstrances from persons interested in or affected by the same,

WHEREAS, a public hearing was held on August 12, 1975 at which time, persons interested in or affected by said proceedings were given the opportunity to be heard and introduce evidence on the questions to be determined, and

WHEREAS, there have been no remonstrances filed herein, and WHEREAS, the Board of Trustees of the Town of Dyer, has determined that it is in the best interest of the Town to vacate such walkway and add a proportionate part of such walkway to the abutting land.

NOW, THEREFORE, BE IT ORDAINED by the Board of Trustees of the Town of Dyer, Lake County, Indiana as follows:

That the public walkway lying between 845 and 849 Tyler

Street and 904 and 908 Harrison Street, be vacated and that the

Board of Trustees and the Town Attorney proceed to petition the Lake

Circuit Court to vacate such public way and add to the abutting land

a proportionate part of such public walkway.

# REGULAR TOWN BOARD MEETING V Tuesday, August 12, 1975

The Board of Trustees of the Town of Dyer met in regular session at 8 p.m. Present were: Trustee Thomas Jacobs, Glen Eberly and William McCambridge; Town Attorney, Michael Muenich, and Clerk-Treasurer, Donna Jones.

# Public Hearing:

This being the date set for public hearing on Preliminary Ordinance #954 providing for the vacation of a public walkway lying between 845 and 849 Tyler Avenue and 904 and 908 Harrison Avenue and providing for the addition of a proportionate part of such walkway to the abutting land.

The Clerk-Treasurer presented Proof of Publication in The Times newspaper on July 29 and August 5, and Proof of Posting same on the 17th of July in Hoffman's Super Market, Gary National Bank, and Cataldi Drugs.

Trustee Jacobs read in full a draft of Ordinance #955 confirming the above Ordinance. He called three (3) times for written and oral remonstrances respectively. The Board unanimously approved the following:



Motion was made by Trustee McCambridge seconded by Trustee Eberly and carried.
- Preliminary Ordinance #957 transferring \$900.00 from the Revenue Sharing Trust Account to Revenue Sharing Fund 7-72 for the purchase of Summer Park Program equipment, and authorizing a public hearing on the matter on September 9, 1975. Motion was made by Trustee Eberly seconded by Trustee McCambridge and carried.
- \*\* Preliminary Ordinance #958 appropriating \$2750.00 from the Cumulative Capital Improvement Fund to the Services Contractual Fund for the purpose of moving donated structures to Town property, and authorizing that a public hearing be held on the matter on September 9, 1975. Motion was made by Trustee McCambridge seconded by Trustee Eberly and carried.
- Preliminary Ordinance #959 appropriating \$2000.00 from the Federal Revenue Sharing Trust Account to the General Land Purchase Fund for the purchase of land adjacent to the Pheasant Hills Park property and authorizing a public hearing on the matter on September 9, 1975. Motion was made by Trustee Eberly seconded by Trustee McCambridge and carried.
