PARCEL "A" OF TRACT 2, LINCOLN RIDGE:

DESCRIPTION: Part of Tract 2 of Lincoln Ridge, a planned unit development in the Town of Schererville, Lake County, Indiana, as shown in Plat Book 59, page 47 in the Office of the Recorder of Lake County, Indiana, which part of said Tract 2 is more particularly described as follows:

Commencing at the Southwesterly corner of said Tract 2; thence North 21° 19' 29" East, along the Westerly line of said Tract 2, a distance of 83.17 feet to the place of beginning; thence continuing North 21° 19' 29" East, along said Westerly line, a distance of 176.83 feet to the Northwesterly corner of said Tract 2; thence Easterly, along the Northerly line of said Tract 2, on a curve concave to the Southwest and having a radius of 4221.2 feet, an arc distance of 43.06 feet to a point on the Northerly extension of the Westerly wall face of the existing 1 story concrete block commercial building situated on Tracts 1 and 2 of said Lincoln Ridge; thence South 23° 12' 44" West, along the extended line of said Westerly building wall face, a distance of 116.27 feet; thence South 54° 15' 54" West, a distance of 72.15 feet to the place of beginning, containing 0.1371 Acres, more or less, all in Schererville, Lake County, Indiana.
