

All that part of the North half of the Northeast Quarter of Section 2, Township 23 North, Range 9 West of the Second Principal Meridian in the Town of Griffith, lying South of the 100-foot right of way of the Elgin, Joliet and Eastern Railroad and North of the 300-foot right of way of the Grand Trunk Railroad, except the East 1200 feet thereof, and except a triangular shaped parcel of land described as commencing at a point in the South line of said North half of the Northeast Quarter that is 1200 feet West of the East line of said Northeast Quarter; thence Northward on a line parallel to and 1200 feet West of the East line of said Northeast Quarter 510.75 feet more or less to a point 1013.40 feet South of the North line of said Northeast Quarter; thence Southwestward in a straight line 679.29 feet to a point in the South line of said North Half of the Northeast Quarter that is 1637.36 feet West of the East line of said Northeast Quarter, being the intersection of said South line with the North line of the Grand Trunk Railroad; thence East on said South line of the North half of the Northeast Quarter 437.36 feet to the point of beginning, and also excepting real estate conveyed to LaSalle Steel Company, a Delaware Corporation, in Corporate Deed recorded August 28, 1980, as Document No. 596229 in Lake County, Indiana. 
