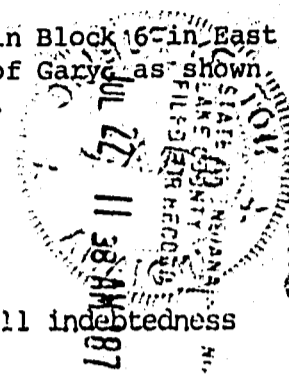

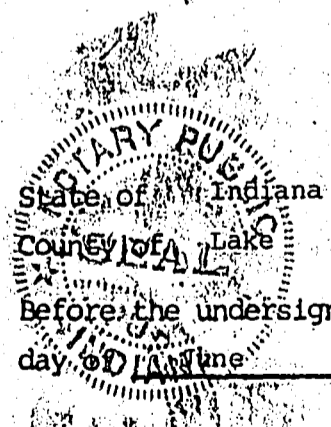
This mortgage is given to the mortgagee for the purpose of securing all indebtedness already owing by Patricia Hunter, A/K/A Patricia Ann Hunter
