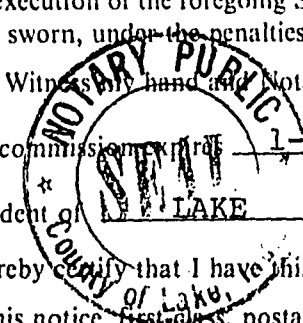

SCHEDULE "A"

LEGAL DESCRIPTION

Parcel A KEY 37-75-9

That part of the Southeast Quarter of Section 30, Township 37 North, Range 9 West of the Second Principal Meridian, described as follows, to-wit: Beginning at the Northeast corner of the Southeast Quarter of Section 30 aforesaid, thence South on the East line of said Section 30, a distance of 54.8 feet to a point in the Northwesterly line of the right of way of the Baltimore and Ohio Chicago Terminal Railroad Company, thence Southwesterly on a curve convexed to the Southeast with a radius of 1507.3 feet, a distance of 1375 feet to a point on the North line of the right of way of the South Chicago and Southern Railway Company, said point being 1202.24 feet West of the East line of said Section 30, thence West on the North line of the right of way of said South Chicago and Southern Railway Company, a distance of 1442.31 feet to the West line of the Southeast Quarter of said Section 30, thence North on the West line of the Southeast Quarter of said Section 30, a distance of 603 feet to the Northwest corner thereof, thence East on the North line of said Southeast Quarter of Section 30, a distance of 2644.8 feet to the place of beginning, in the City of Hammond, in Lake County, Indiana.
