An easement fifteen (15) feet in width beginning at a point 330 feet west of the southeast corner of Section 2, Township 34 North, Range 9 West and the north right-of-way line of State Route 231, thence west, lying north of, parallel and abutting the north right-of-way line of State Route 231 for a distance of 385 feet more or less.
