and other valuable consideration, the receipt whereof is hereby acknowledged,

the following described Real Estate in Lake County

in the State of Indiana, to-wit: 40-33-35

That part of the following described tract: Part of the Northeast quarter of Section 6, Township 36 North, Range 8 West of the 2nd P.M., described as follows: All of that part of said quarter section lying South of the South line of U. S. Highway #12 as the same was described by Parcel #12, in Instrument of Dedication to public by Gary Land company, dated April 29, 1936, and recorded May 19, 1936, in Book 546, page 69, in the Recorder's Office of Lake County, Indiana, and North of a line which is 205 feet North of and parallel with the center line of 5th Avenue, said parcel being bounded on East side by a line at right angle to the center line of said highway U. S. #12 at a distance of 927.8 feet West of the intersection of center line of said Highway U. S. #12 with the center line of Industrial Highway as the same was opened by Board of Public Works of City of Gary by Confirmatory Resolution #3158 adopted April 17, 1922 and recorded in Miscellaneous Record 120, page 193, in the Recorder's Office of Lake County, Indiana, and on the West side by a line 25 feet East of and parallel with the West line of said Northeast quarter of Section 6, said part and portion of above described tract herein conveyed being more particularly described as Commencing at the Northeast corner of said above tract and running thence Westerly along the North line thereof, 200 feet, thence South parallel with the West line of the Northeast quarter of Section 6, to the South line of said above described tract, thence East along the South line of said tract to the Southeast corner thereof, thence North along the East line thereof to the place of beginning in the City of Gary, Lake County, Indiana.
