And it appearing that no objections were filed thereto and the Court being fully advised in the premises, now finds that:

- 1. Due notices of the filing of said account and petition and of the hearing on the same were given to all persons interested in said estate and the same are now properly before the Court for final action thereon.
- 2. That William B. Bartok, Jr., died intestate, a resident of the County of Lake, State of Indiana, on the 25th day of September, 1977, and said personal representative was issued Letters of Administration on the 8th day of May, 1987, to her and since that date she has continued to serve in such capacity.
- That the matters and things stated in said account and petition are true and that said personal representative has accounted for all of the assets in this estate coming into her hands.
- More than five (5) months have elapsed since the date of the first-published notice to the heirs and creditors of said decedent; all claims filed against said estate have been paid and discharged; neither said decedent not his personal representative were employers of labor within the meaning of that term as used in the Indiana Employment Security Act; all estate taxes, inheritance taxes and gross income taxes, if any, assessed in said estate have been paid.
- That the decedent died leaving the following heirs at law pursuant to the provisions of Indiana Code, I.C.

4. Said personal representative having made distribution of all assets and property and having attached vouchers evidencing said distribution to the decedent's heirs, said distribution is hereby approved and confirmed.
