And it appearing that no objections were filed thereto and the Court being fully advised in the premises now finds that:

- 1. Due notices of the filing of said account nad petition and of the hearing on the same were given to all persons interested in said estate, and the same are now properly before the Court for final action thereon.
- 2. That Willie L. Laster , died testate, a resident of the County of Lake, State of Indiana, on December 20, 1974, and his Last Will and Testament was duly admitted to probate before this Court on December 27, 1974, and this Court appointed said Lydia Laster as executrix of the Last Will and Testament of the decedent, and said executrix was issued Letters of Testamentary on December 27, 1974, to her and since that date she has continued to serve in such capacity.
- 3. That the matters and things stated in said account and petition are true, and that said executrix has accounted for all the assets in said estate coming into her hands.
- 4.
