AMENDED MEMORANDUM OF LEASE

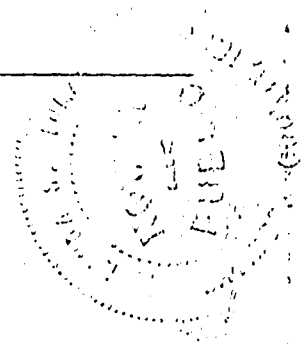
