istrators, successors and assigns, jointly and severally, firmly by these presents.

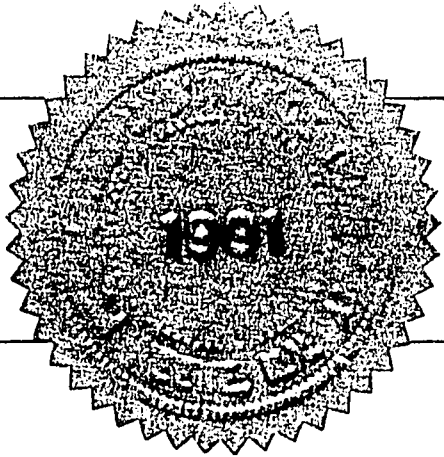
