representative of the Last Will and Testament of the decedent, and said Executor was issued Letters Testamentary on the 1st day of July, 1986, and since that date he has continued to serve in such capacity.

3. That the matters and things stated in said account and petition are true, and that said Executor has accounted for all the assets in said estate coming into his hands.

4. More than five (5) months have elapsed since the date of the first published notice to legatees, devisees and creditors of said decedent; all claims filed against said estate have been paid and discharged; neither said decedent nor her Executor was an employer of labor within the meaning of that term as used in the Indiana Employment Security Act; all estate taxes, inheritance taxes and gross income taxes, if any, assessed in said estate have been paid. The fees requested by Attorney Gregory A. Sobkowski in the sum of \$850.00, and the Executor's commission in the sum of \$-0- are reasonable and proper.

5. The following persons are the sole legatees and devisees under the decedent's Last Will and Testament: All to Cecilia M. Kruchowsky, and that all assets and property of this estate remaining after payment of decedent's debts and expenses of administration have been distributed to the above-named person.

6. That the decedent owned a certain piece of real estate located at 413 Pennsylvania Street, Gary, Indiana, in the County of Lake, State of Indiana, more particularly described as follows:

All of Lot 29, in Block 109, of Gary Land Company's First Subdivision, in the City of Gary, as recorded in the Recorder's Office of Lake County, Indiana.

and that said real estate vested in Cecilia M. Kruchowsky upon the decedent's death as part of the residuary estate.

IT IS, THEREFORE, ORDERED, ADJUDGED AND DECREED by the Court as follows:

1. Said Final Report and Account of said Executor is hereby in all things approved, settled and confirmed.

2. That the Executor is authorized and directed to pay attorney's fees in the sum of \$850.00 to Gregory A. Sobkowski and an Executor's commission in the sum of \$-0- to John D. Kruchowsky.

3. That the distribution of the balance of the property remaining in said Executor's hands for distribution has been made pursuant to the distribution set forth in the final accounting as prescribed under the Last Will and Testament of said decedent and is hereby in all things approved.

4. That pursuant to the decedent's Last Will and Testament, the following described real estate is hereby vested in Cecilia M. Kruchowsky pursuant to the provisions of the decedent's Last Will and Testament, to-wit:

All of Lot 29, in Block 109, of Gary Land Company's First Subdivision, in the City of Gary, as recorded in the Recorder's Office of Lake County, Indiana.

And that said Executor is hereby directed to procure and record in the office of the Recorder of Lake County, being the county in which said real estate is located, a certified copy of this Final Decree.

5. Said Executor having made distribution of all assets and property, said distribution is hereby approved and confirmed.

6. Said Executor is hereby released and discharged from any further liability or responsibility along with surety, if any, as said Executor of the estate.
