PETITION FOR ORDER APPROVING DISTRIBUTION & CLOSING ESTATE

This cause came to be heard on the 29 day of 1988, upon the final account, petition to settle and allow account, and for authority to distribute estate filed by Josephine Anton, as Executrix of the estate of Jiovana Greco, deceased, which account and petition are in the words and figures following, to-wit:

And it appearing that no objections were filed thereto and the Court being fully advised in the premises now finds that

- Due notices of the filing of said account and petition and of the hearing on the same were given to all persons interested in said estate, and the same are now properly before the Court for final action thereon.
- That Jiovana Greco, died testate, a resident of the County of Lake, State of Indiana, on the 9th day of October, 1982, and her Last Will and Testament was duly admitted to probate before this Court on the 25th day of January, 1985, and this Court appointed said Josephine Anton as personal representative of the Last Will and Testament of the decedent,

and said Executrix was issued Letters Testamentary on the 25th day of January, 1985, and since that date she has continued to serve in such capacity.

- 3. That the matters and things stated in said account and petition are true, and that said Executrix has accounted for all the assets in said estate coming into her hands.

- 3. That the distribution of the balance of the property remaining in said Executrix's hands for distribution should be made pursuant to the distribution set forth in the final accounting as prescribed under the Last Will and Testament of said decedent and is hereby in all things approved.
- 4. That pursuant to the decedent's Last Will and Testament, the following described real estate is hereby vested in Gean Hootnick, Rose Mary Wilson and Josephine Anton pursuant to the provisions of the decedent's Last Will and Testament, to-wit:
