EXECUTRIX'S FINAL REPORT AND ACCOUNTING,
PETITION TO ALLOW ACCOUNTING, AND
PETITION FOR ORDER APPROVING DISTRIBUTION & CLOSING ESTATE

This cause came to be heard on the 24TH day of June,
1988, upon the final account, petition to settle and allow
account, and for authority to distribute estate filed by
Josephine Anton, as Executrix of the estate of Jiovana Greco,
deceased, which account and petition are in the words and
figures following, to-wit:

And it appearing that no objections were filed thereto and
the Court being fully advised in the premises now finds that:

1. Due notices of the filing of said account and petition
and of the hearing on the same were given to all persons
interested in said estate, and the same are now properly before
the Court for final action thereon.

2. That Jiovana Greco, died testate, a resident of the
County of Lake, State of Indiana, on the 9th day of October,
1982, and her Last Will and Testament was duly admitted to
probate before this Court on the 25th day of January, 1985, and
this Court appointed said Josephine Anton as personal
representative of the Last Will and Testament of the decedent,

and said Executrix was issued Letters Testamentary on the 25th day of January, 1985, and since that date she has continued to serve in such capacity.

3. That the matters and things stated in said account and petition are true, and that said Executrix has accounted for all the assets in said estate coming into her hands.

4. More than five (5) months have elapsed since the date of the first published notice to legatees, devisees and creditors of said decedent; all claims filed against said estate have been paid and discharged; neither said decedent nor her Executrix was an employer of labor within the meaning of that term as used in the Indiana Employment Security Act; all estate taxes, inheritance taxes and gross income taxes, if any, assessed in said estate have been paid. The fees requested by Attorney Gregory A. Sobkowski in the sum of \$1,750.00, and the Executrix's commission in the sum of \$-0- are reasonable and proper.

5. The following persons are the sole legatees and devisees under the decedent's Last Will and Testament:

said distribution should be made to the above-named person(s) as set forth above.

6. That the decedent owned a certain piece of real estate located at 3755 Washington Street, Gary, Indiana, in the County

of Lake, State of Indiana, more particularly described as follows:

Lot 24, 25, Block 1, South Broadway Land Company's 3rd South Broadway Addition to Gary, as shown in Plat Book 8, page 3 in the Office of the Recorder of Lake County, Indiana.

and that the decedent devised said real estate in Article IV of the decedent's Last Will and Testament to Gean Hootnick, Rose Mary Wilson and Josephine Anton.

IT IS, THEREFORE, ORDERED, ADJUDGED AND DECREED by the Court as follows:

1. Said Final Report and Account of said Executrix is hereby in all things approved, settled and confirmed.

2. That the Executrix is authorized and directed to pay attorney's fees in the sum of \$1,750.00 to Gregory A. Sobkowski and an Executrix's commission in the sum of \$-0- to Josephine Anton.

3. That the distribution of the balance of the property remaining in said Executrix's hands for distribution should be made pursuant to the distribution set forth in the final accounting as prescribed under the Last Will and Testament of said decedent and is hereby in all things approved.

4. That pursuant to the decedent's Last Will and Testament, the following described real estate is hereby vested in Gean Hootnick, Rose Mary Wilson and Josephine Anton pursuant to the provisions of the decedent's Last Will and Testament, to-wit:

Lot 24, 25, Block 1, South Broadway Land Company's 3rd South Broadway Addition to Gary, as shown in Plat Book 8,

page 3 in the Office of the Recorder of Lake County, Indiana.

5. Said Executrix is hereby directed to distribute the balance of the assets available for final distribution pursuant to the provisions of the decedent's Last Will and Testament as follows:





All of which is ordered this 24TH day of June, 1988.




