# SATISFACTION OF MORTGAGE

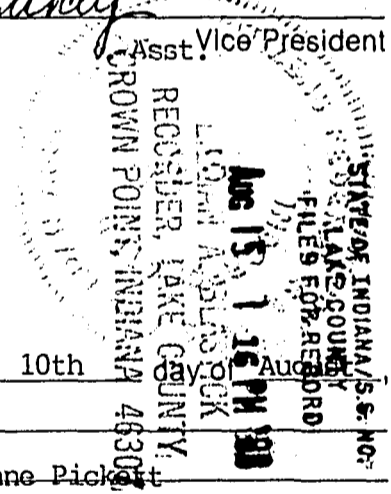
