4. More than five (5) months have elapsed since the date of the first published notice to the heirs and creditors of said decedent; all claims filed against said estate have been paid and discharged; neither said decedent nor her personal representative was an employer of labor within the meaning of that term as used in the Indiana Employment Security Act; all estate taxes, inheritance taxes and gross income taxes, if any, assessed in said estate have been paid.

5. That the decedent died leaving the following heirs at law pursuant to the provisions of Indiana Code, I.C. 29-1-2-1:

and that said decedent died unmarried, leaving no other child or children, nor descendants of any predeceased child or children, other than those enumerated above.

1. Said Final Report and Account of said personal representative is hereby in all things approved, settled and confirmed.

2. That the distribution of the balance of the property remaining in said personal representative's hands for distribution

has been made pursuant to the distribution set forth in the final accounting and is hereby in all things approved.


3. That the following described real estate, to wit:

Locust Terrace, East 37 1/2 feet, Lot 10 (Key No. 34-283-14) commonly known as 48 Locust Street, Hammond, Indiana, reverts to Roy E. Huebner.

And that said personal representative is hereby directed to procure and record in the office of the Recorder of Lake County, being the county in which said real estate is located a certified copy of this Final Decree.

4. Said personal representative having made distribution of all assets and property and having attached receipts or vouchers evidencing said distribution to the decedent's heirs, said distribution is hereby approved and confirmed.

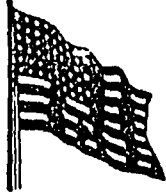
