GIOVANNINA BONFIGLIO, Executrix of the Estate of Tindaro Bonfiglio, deceased, now appears for hearing upon her Final Account, which Final Account is as follows: (H.I.).

And the Court, it appearing that no objections were filed to this Final Account, and being fully advised, now finds as follows:

1. Due notices of the filing of the Final Account and of the hearing on same were given to all persons interested in the estate and the same are properly before the Court for final action.
2. Tindaro Bonfiglio died intestate a resident of Cook County, Illinois on August 2, 1986. Ancillary Letters of Testamentary were issued to Giovannina Bonfiglio on October 27, 1987 and since that time she has continued to serve in such capacity.
3. The matters and things stated in the Final Account are true and Giovannina Bonfiglio has accounted for all of the assets in this estate coming into her hands.
4. More than five (5) months have elapsed since the date of the first published notice to the heirs and creditors of Tindaro Bonfiglio. All claims filed against this estate have been paid and discharged. Neither Tindaro Bonfiglio nor his Executrix were employers of labor within the meaning of that term as used in the Indiana Employment Security Act. All estate taxes, inheritance taxes and gross income taxes, if any, assessed in this estate, have been paid.
5. The decedent owned no real estate at the time of his death other than a piece of real estate located in Lake County, Indiana more particularly described as follows:
