NOW THE CONDITION OF THIS OBLIGATION IS SUCH,

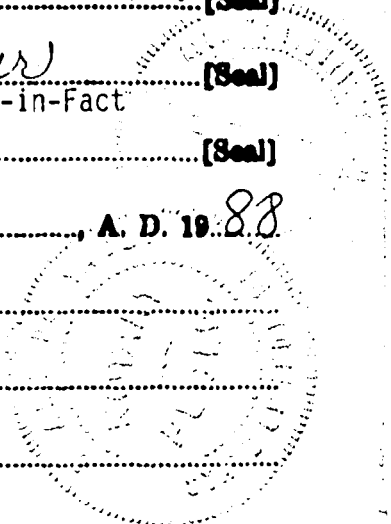
