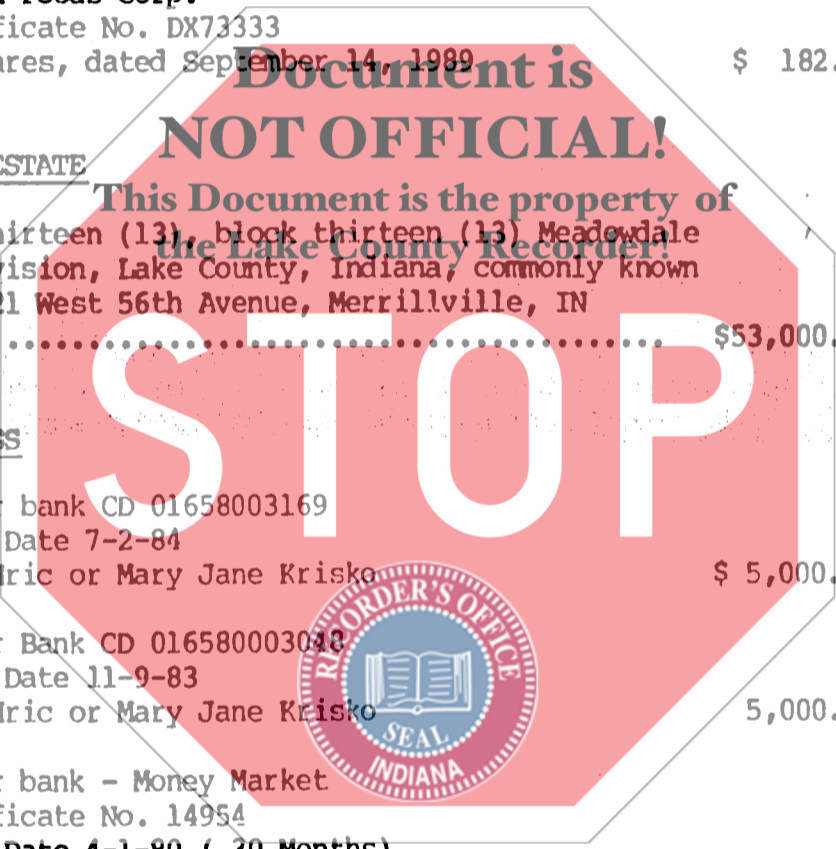


IT IS FURTHER ORDERED, ADJUDGED AND DECREED that Mary Jane Krisko is the owner of the following described real estate:
