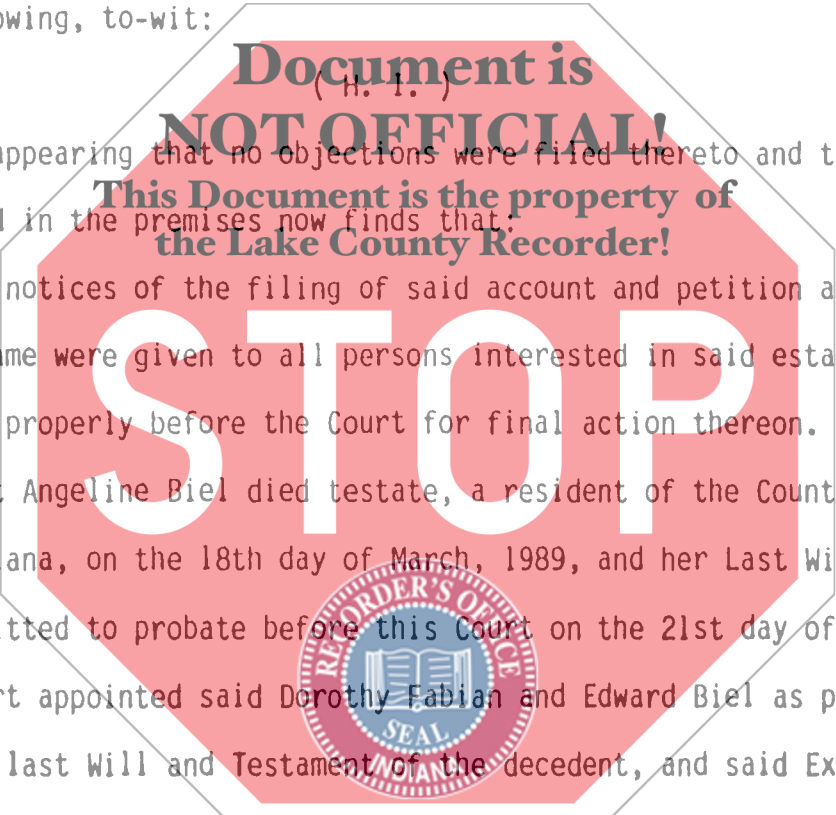

ORDER APPROVING EXECUTORS' FINAL REPORT
AND ACCOUNTING, PETITION TO ALLOW ACCOUNTING, AND
PETITION FOR ORDER APPROVING DISTRIBUTION AND CLOSING ESTATE
LAKE SUPERIOR COURT

This cause came to be heard on the 16 day of FEBRUARY 1990 upon the final account, petition to settle and allow account, and for authority to distribute estate filed by Edward Biel and Dorothy Fabian, as Executors of the Estate of Angeline Biel, deceased, which account and petition are in the words and figures following, to-wit:

And it appearing that no objections were filed thereto and the court being fully advised in the premises now finds that:

1. Due notices of the filing of said account and petition and of the hearing on the same were given to all persons interested in said estate, and the same are now properly before the Court for final action thereon.
2. That Angeline Biel died testate, a resident of the County of Lake, State of Indiana, on the 18th day of March, 1989, and her Last Will and Testament was duly admitted to probate before this Court on the 21st day of April, 1989, and this Court appointed said Dorothy Fabian and Edward Biel as personal representatives of the last Will and Testament of the decedent, and said Executors were issued Letters Testamentary on the 21st day of April, 1989, to them and since that date has continued to serve in such capacity.
3. That the matters and things stated in said account and petition are true, and that said Executors have accounted for all the assets in said estate coming into their hands.
4. More than five (5) months have elapsed since the date of first published notice to legatees, devisees and creditors of said decedent; all claims filed against said estate have been paid and discharged; neither said decedent nor her Executors were an employer of labor within the meaning of that term as used in the Indiana Employment Security Act; all estate taxes, inheritance taxes and gross income taxes, if any, assessed in said estate have been paid.

5. The following persons are the sole legatees and devisees under the decedent's Last Will and Testament: Edward Biel and Dorothy Fabian and that all assets and property of this estate remaining after payment of decedent's debts and expenses of administration have been distributed to the above-named persons, as evidenced by their voucher, which is attached hereto and made a part of this accounting.

6. That the decedent owned a certain piece of real estate located at 250 N. Lake Park Avenue in the County of Lake, State of Indiana, more particularly described as follows:

Key # 18-137-11

North ½ of Lot 8, as marked in Rifenberg's Addition to the City of Hobart, plat Book 1, Page 5, in the Office of the Recorder of Lake County.

Said real estate now vests in legatees, Dorothy Fabian and Edward Biel.

IT IS, THEREFORE, ORDERED, ADJUDGED AND DECREED by the Court as follows:

1. Said Final Report and Account of said Executors is hereby in all things approved, settled and confirmed.
2. That the distribution of the balance of the property remaining in said Executors' hands for distribution has been made pursuant to the distribution set forth in the final accounting as prescribed under the Last Will and Testament of said decedent and is hereby in all things approved.
3. Said Executors having made distribution of all assets and property and having attached vouchers evidencing said distribution to said legatees and devisees, said distribution is hereby approved and confirmed.
4. Said Executors are hereby released and discharged from any further liability or responsibility as said Executors of the Estate of Angeline Biel, deceased.
