- 3. Said Executors having made distribution of all assets and property and having attached vouchers evidencing said distribution to said legatees and devisees, said distribution is hereby approved and confirmed.
- 4. Said Executors are hereby released and discharged from any further liability or responsibility as said Executors of the Estate of Angeline Biel, deceased.
