(2) The matters and things stated in said petition and account are true and said executrix has accounted for all assets of said estate coming into her hands.

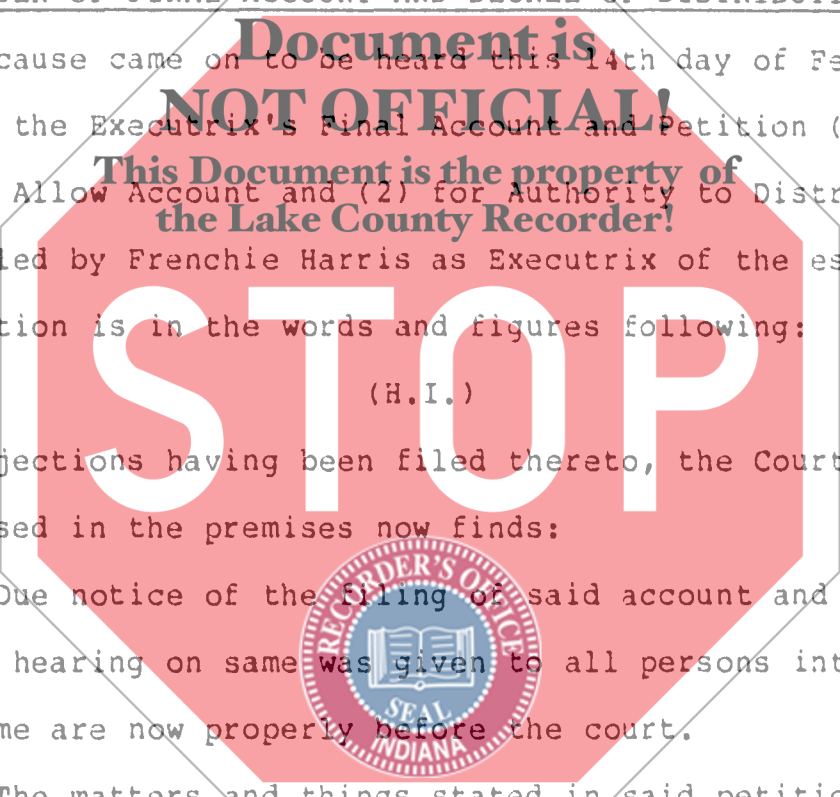
(3) The amount claimed as credit for attorney fees has previously been approved and allowed by the Court in the amount of \$3,016.00.

(4) More than five months have elapsed since the date of the first published notice to the heirs and creditors; all claims filed against said estate have been paid except those set out in paragraph (5) and those incidental to closing said estate; neither this decedent nor his executrix was an employer of labor as that term is defined under Indiana Law; all inheritance tax due the State of Indiana has been paid and the estate was not subject to Federal Estate Tax.

(5) That the court now finds that certain claims and expenses have not been paid as follows:

a.	Frenchie Harris	\$14,998.58
b.	Jacob Harris	1,485.85
c.	Robert Oates	<u>3,016.00</u>

TOTAL \$19,400.43

And that said claims and expenses should constitute a lien on the real estate until paid.

(1) The final account is hereby in all respects approved, settled, allowed and confirmed.

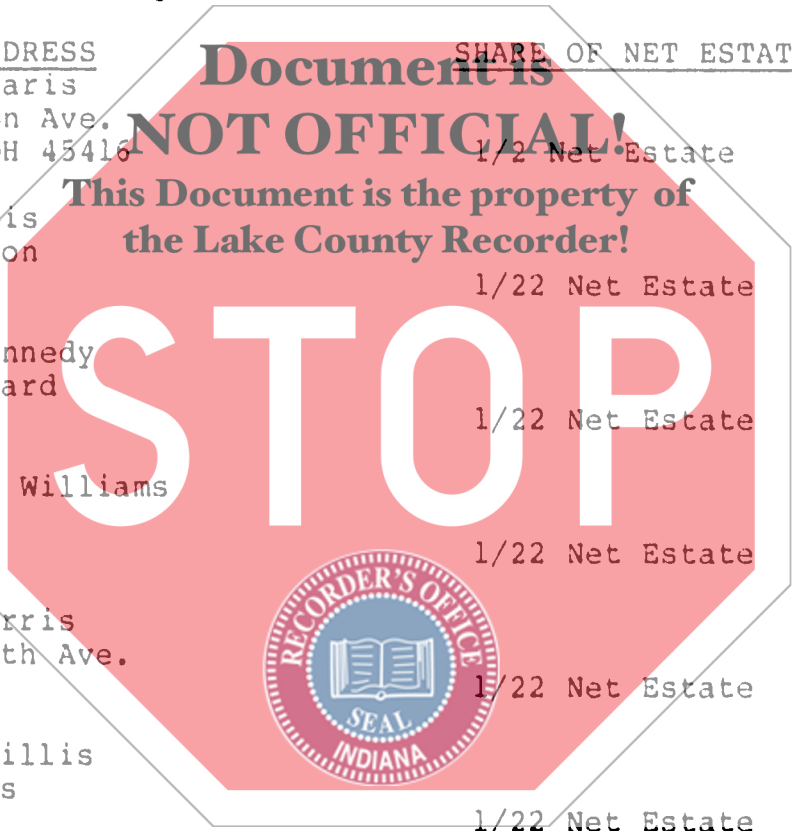
(2) The amount claimed as credit for attorney fees has

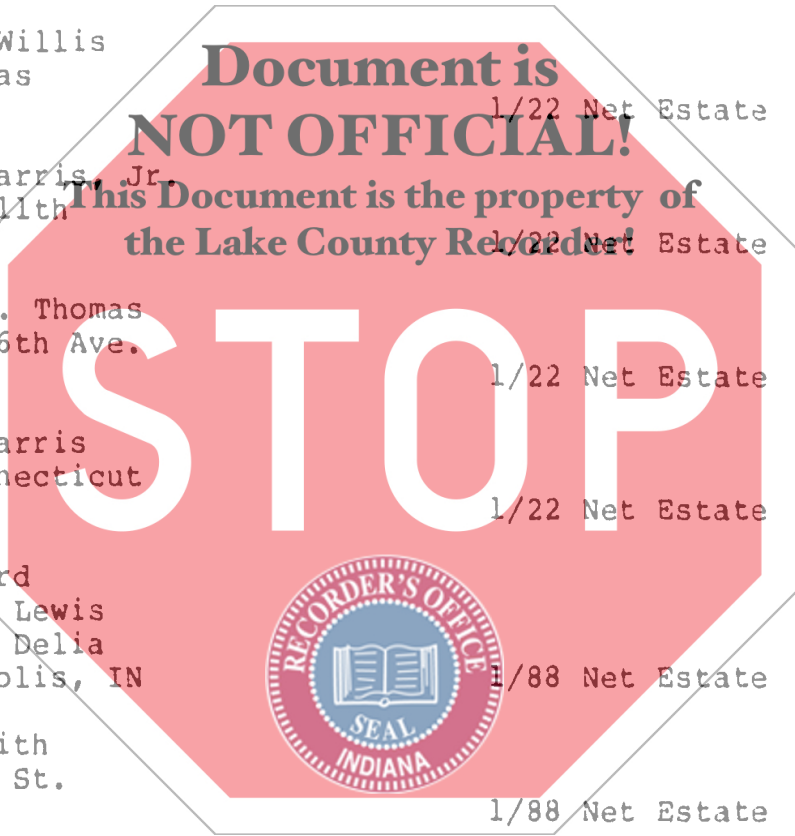
