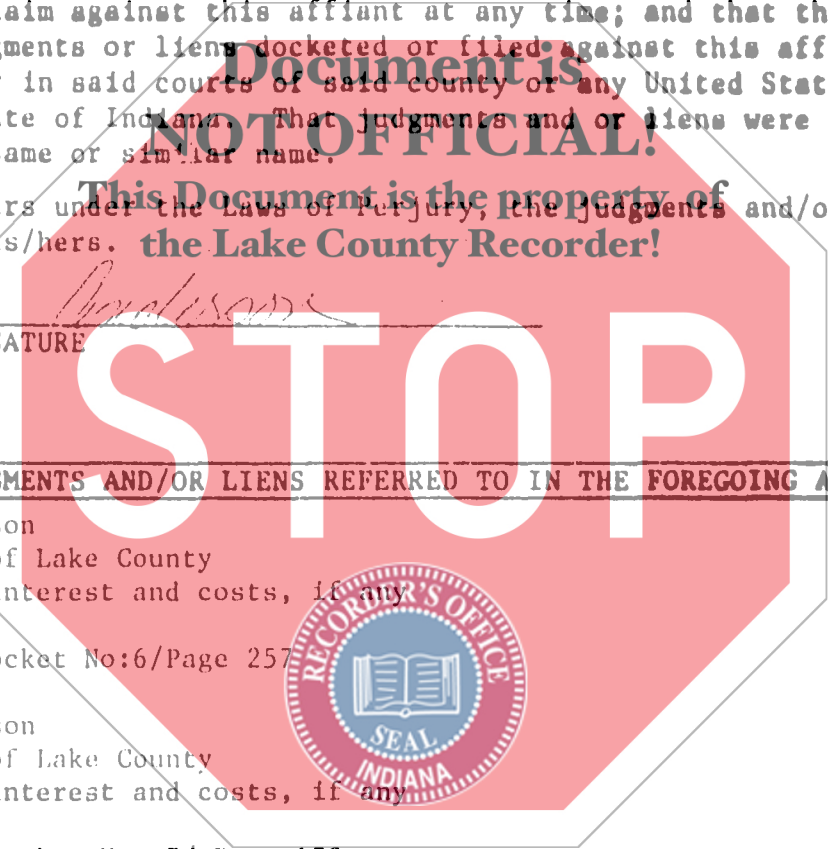
Rebecca J Anderson, being first duly sworn, deposes and says:
