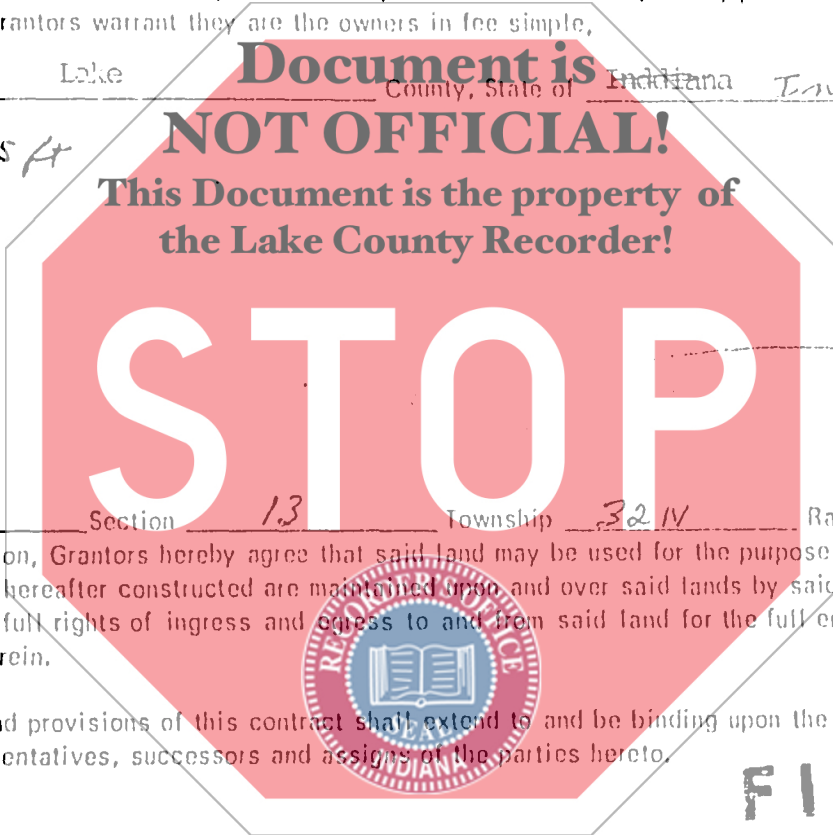
FOR AND IN CONSIDERATION OF THE SUM OF One thousand Dollars <sup>00</sup>/<sub>100</sub> DOLLARS
