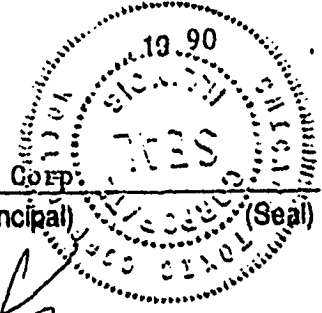

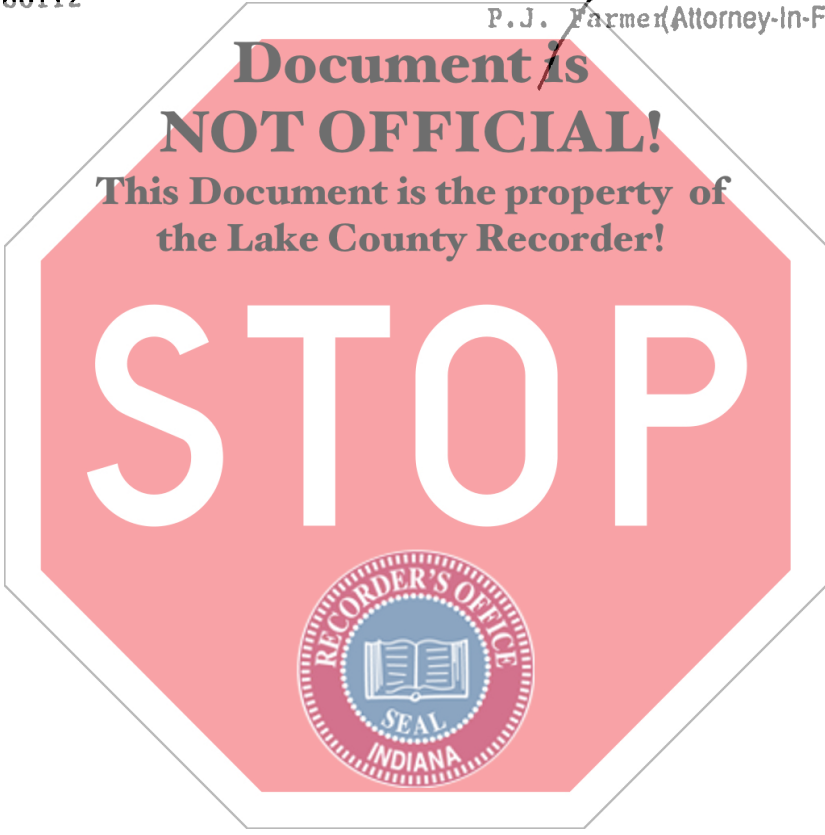

POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS:

That Evanston Insurance Company ("Corporation"), a corporation organized and existing under the laws of the State of Illinois, with its main office at Shand Morahan Plaza in the City of Evanston, Illinois, does hereby nominate, constitute and appoint, for the purpose stated herein, Talbert Corporation (Talbert), Denver, Colorado, its true and lawful attorney-in-fact, with full power and authority to make, execute and deliver, for and on its behalf as surety, and as its act and deed, payment or performance bonds in amounts up to \$500,000 per assured and bid, license, permit, or fringe benefit bonds in amounts up to \$100,000 per assured, to members of Environmental Risk Insurance Company, A Risk Retention Group (ERIC), Denver, Colorado, and the execution of such bonds in pursuance of these presents shall be as binding upon said Evanston Insurance Company to all intents and purposes as if duly executed by its Chairman, President or Senior Vice President for Underwriting, sealed with its corporate seal, and attested by its Secretary or Assistant Secretary.

This Power of Attorney shall only be valid as evidenced in original form; no copy, certified or otherwise, shall have any validity or effect. This Power of Attorney is made and executed by authority of a resolution adopted by the Board of Directors, of which the following is a true and exact copy: "RESOLVED: That, pursuant to Section 8.6 of the By-Laws of the Corporation, the Chairman, President, or Senior Vice President for Underwriting, with the Secretary or Assistant Secretary, is hereby authorized to appoint Talbert Corporation, Denver, Colorado, acting through its president, B.R. Clark, of Robert J. Surich, Carol Bronder, P.J. Farmer, or E.A. Houser, III, its Bond Department Vice Presidents, as the Corporation's attorney-in-fact with authority to make and execute on behalf of the Corporation, in Illinois and States where the Corporation is qualified to act as a surplus lines insurer, payment or performance bonds in amounts up to \$500,000 per assured and bid, license, permit, or fringe benefit bonds in amounts up to \$100,000 per assured, such bonds to be issued to members of Environmental Risk Insurance Company, A Risk Retention Group; also to execute such instruments as may be necessary or proper in connection with the settlement of claims or the recovery of reinsurance or salvage."

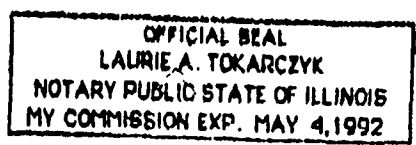
